We are super excited to have you as a scholarship student and that we are here to help you further your dance education. As a studio scholarship student, there are some requirements that may need to be met or agreed upon.

Once a part of the scholarship program, we ask that you uphold the rules and regulations of the dance studio and represent the studio to the best of your abilities. We ask that you take being on this program very seriously and not take it for granted, as there are many students that would love to have the opportunity.

There are many kinds of scholarship options the studio offers. It is important to understand there are no full scholarships. There is to be some sort of fee paid for each type of expense. Below, we will need to detail the outline of your scholarship. We will detail what the studio is responsible for, what you as a dancer are responsible for and what parents/guardians may be responsible for. If at any time you/your parent/guardian are unable to uphold your end of the agreement, we ask that you come to us and see if we can rearrange the terms of the agreement. Because this program is often sponsored by outside donors, as well as the studio itself generously donating time and supplies we take each case under consideration and what they may need. This form helps create an algorithm of how to customize each scholarship and its details and how to allocate what you pay and the funds donated. We operate this program on a sliding scale and are based on income eligibility and how many service hours you/your dancer can donate etc... Assisting in classes has its own set of rewards/benefits and sometimes can overlap with this program, however we like to keep that program separate from the scholarship hours/benefits.

We also require that should your needs change that you are upfront with us and assume what you are able or let us know if something more needs added.
